CALL TO ORDER: The meeting was called to order at 5:34 p.m.

ATTENDANCE: Linda EVB, Mikey Lund, Bill O'Neil, Scott Drechsler and Lori Casey. Absent Alexis Leitgeb and Victor Modjeski. Also in attendance were Manager Tim Cooper, and Superintendent Justin Hirdler.

MINUTES: Scott Drechsler moved to accept amended minutes of August 25, 2020. The motion was seconded by Bill O'Neil and approved 5-0.

NEW & OLD BUSINESS

1. President's Report – EVB
 Resignation of board member Victor Modjeski was not accepted at this time. His official resignation is pending.
2. Treasurer's Report: 9/14/2020
3. Superintendent's Report – Hirdler
 (a) Projects completed this year were installing the intake pond bubbler aerators; fixing irrigation lines; punching holes in greens to reduce thatch; verticutting greens to promote new plant growth; sanding greens for a healthier playing surface; and verticutting and punching tees. Thanks to many volunteers who fixed and painted buildings/shelters; made and installed a new water cooler; and cut trees to improve play and create healthier turf. (b) Upcoming tasks include aeration of tees, fairways and greens; deep tining of greens for winter drainage, sanding greens two more times; completing #6 forward tee box; spraying for winter protection against disease; and general course closure duties. (c) Justin thanked Artisensi, Perko, and all leagues and individuals who generously donated time and money to improve our club. He also thanked Curt Johnson for helping with the tree and leveling project on #9.
4. Building & Grounds: Drechsler continues to research costs of paving old/new cart paths.
5. Manager's Report: Manager Cooper
 As you all know COVID threw us a curve ball but I think we hit it out of the park anyway. I looked back in Quick Books, and this year is the best we have had since 2011! 
